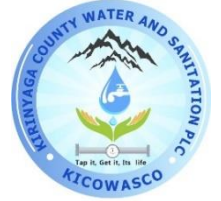

### A. INVITATION FOR APPLICATION FOR VACANT POSITIONS IN THE BOARD OF DIRECTORS OF KIRINYAGA COUNTY WATER AND SANITATION PLC

Kirinyaga County Water and Sanitation PLC (KICOWASCO) is a company wholly owned by the County Government of Kirinyaga. It is responsible for efficient and economical provision of Water and Sanitation Services in Kirinyaga as per the Water Act 2016.

The company seeks to fill the vacant positions for the Board of Directors. The Board of Directors comprises of representatives of Stakeholders identified by the company within its area of jurisdiction. The company has three (3) board vacancies for representatives of the following stakeholders;

1. One (1) director representing Commercial Consumers
2. One (1) director representing Religious Organizations.
3. One (1) director representing Professional Bodies.

#### ELIGIBILITY

To be eligible for an appointment, one must meet the following criteria;

- i. Minimum Bachelor's degree from a recognized university.
- ii. Minimum seven (7) years working experience in the core profession or have run own enterprises for a minimum of 7 years.
- iii. Must be nominated by a stakeholder group registered by the company.
- iv. Must be a resident of the area served by the company.
- v. Must meet the requirements of Chapter 6 of the Constitution of Kenya.

- b) Valid Clearance Certificate from Accredited Credit Reference Bureau (CRB).
- c) Valid Clearance Certificate from Higher Education Loans Board (HELB).
- d) Valid Tax Compliance Certificate from Kenya Revenue Authority (KRA).
- e) Valid Clearance Certificate from Ethics and Anti-Corruption Commission (EACC).
- f) Duly filled National Corporate Governance Standards Fit and Proper Test Form (Witnessed by a Commissioner for Oaths/Magistrate).
- g) National Identification Card.
- h) Detailed Curriculum Vitae.

- i) Letter of nomination from stakeholder.
- j) Certified copies of certificates and testimonials.

**NOTE**

- i. Suppliers and other trading associates of the company are not eligible for directorship positions of the company.***
- ii. Persons in the current professional and social relationships with current directors and staff of the company cannot become directors of the company.***
